**ORDER**

**UPON** a case conference having been held on December 6, 2011 in this matter and all of the files listed on Schedule "A" attached hereto (collectively the Files);

**AND UPON** hearing from counsel for the parties and upon reviewing various issues relating to the Files:

**THIS COURT ORDERS that:**

1. The Files shall be referred to the Office of the Chief Justice for the appointment of one or more Case Management Judges.
2. All the Files shall be case managed together by the same Case Management Judge(s).
3. All the Files shall be held in abeyance pending information to be provided by counsel for the Respondent, which information shall be conveyed to the Case Management Judges and to counsel for the Applicants on or before December 20, 2011.
4. A further case conference will be held with the Case Management Judge(s) as soon as reasonably possible in early 2012 to review next steps in the Files.
5. The Respondent is relieved of the requirement to file a Notice of Appearance in each of the Files.
6. Counsel for the Applicants in the Files shall advise the Court Registry and counsel for the Respondent of any additional files which are to be issued involving the same issues as those raised in the Files (the Subsequent Files).
7. All Subsequent Files shall be case managed together with the Files and all Directions or Orders issued with respect to the Files shall apply *mutatis mutandis* to the Subsequent Files.

8. The Court Registry shall file all Orders, Directions, or other documents only in Court File No. IMM-7052-11 until further Order or Direction of the Court and all Files and Subsequent Files shall be cross-referenced to Court File No. IMM-7052-11.


